These factors have led to reduced consumer discretionary spending that has impacted on demand. The Group thus expects a challenging environment for its Built-to-Print, Customised Automation and Semiconductor business segments.

The Group will continue its efforts in managing costs and rationalizing its operations, improve its competitiveness and explore opportunities in new markets to improve its future revenue stream.

The Group and its Board will continue to make efforts and consider various options to meet the requirements of Rule 1314 of the SGX-ST's Listing Manual pursuant to the financial exit criteria and would update its shareholders in due course.
