Aviation Industry Corporation of China holds 62.52% of the registered capital of AVIC International Holding Corporation, which in turn holds holds the entire registered capital of AVIC International Shenzhen Company Limited.

35.6% and 39.4% of the share capital of AVIC International Holdings Limited are directly held by AVIC International Shenzhen Company Limited and AVIC International Holding Corporation respectively.

Prior to AVIC International Holdings Limited's acceptance of the take-over offer for the Listed Issuer, AVIC International Holdings Limited was directly interested in 210,947,369 shares representing 73.87% of the issued and paid up share capital of the Listed Issuer.

Aviation Industry Corporation of China was accordingly deemed interested in the shares of the Listed Issuer held by AVIC International Holdings Limited by virtue of section 7 of the Companies Act.
