	Step 2 :	Complete the information required on registration page and click "Preview".

A6	How do I watch the "live" audio-visual webcast or listen to the "live" audio-only stream of the AGM proceedings?
	Shareholders, including CPF and SRS investors, must <b>pre-register</b> at the pre-registration website at <a href="https://online.meetings.vision/hawpar-agm-registration">https://online.meetings.vision/hawpar-agm-registration</a> from 5 April 2022, 6.00 p.m. till 24 April 2022, 2.00 p.m. (Singapore time) to enable the Company to verify the registrant's status as a shareholder.
	Authenticated registrants will receive an email by <b>26 April 2022</b> , <b>12.00 noon</b> (Singapore time) which will contain the login credentials and the link to access the "live" audio-visual webcast or a toll-free telephone number and a conference code to access the "live" audio-only stream of the AGM proceedings ("Confirmation Email").
	On the day of the AGM (27 April 2022) authenticated registrants will need to click on the link in the email and enter your login credentials to log in to the "live" audio-visual webcast or dial in to the toll-free telephone number and enter the conference code provided in the email to listen to the "live" audio-only stream of the AGM proceedings.

A7	Can I register another person to watch the "live" audio-visual webcast or listen to the "live" audio-only stream on my behalf?
	No. The AGM is a private event. Only HPC shareholders will be able to register to watch the "live" audio-visual webcast or listen to the "live" audio-only stream of the AGM proceedings.



A8	If I hold HPC shares via a securities sub-account in a depository agent (e.g. a nominees' company), can I pre-register for the AGM?
	No. You should contact your depository agent through which you hold your HPC shares as soon as possible in order to make the necessary arrangements for your participation in the AGM.
A9	If I am a CPF and/or SRS investor holding HPC shares, can I pre-register for the AGM?
	Yes, you can pre-register for the AGM through the pre-registration website.

A11	Why do I need to provide my full NRIC/Passport Number?
	This is to enable the Company to verify your identity and status that you are a HPC shareholder.

B1	Will I be able to vote electronically?	
	No, Haw Par Corporation Limited's Constitution currently does not provide for shareholders to vote electronically.	
B2	How do I vote if I can only attend the AGM electronically?	
	Shareholders who wish to vote on the resolutions tabled at the AGM must appoint the Chairman of the AGM as your proxy to attend, speak and vote on your behalf at the AGM, in accordance with the instructions on the proxy form for the AGM.	
	If you appoint the Chairman of the AGM as your proxy, you <b>must give specific instructions</b> as to voting, or abstention from voting, in respect of a resolution in the proxy form, failing which the appointment of the Chairman of the AGM as proxy for that resolution will be treated as invalid.

	Printed copies of the proxy form have been sent by post to shareholders.

Contact number provided will also help the Company to reach out to shareholders if clarification is required.	
	We will not respond to your questions if we are unable to verify your shareholder status.
