## UPDATE REGARDING NOTICE OF CLAIM FROM FORMER EMPLOYEES

The Board of Directors (the "**Board**") of **Asiaphos Limited** (the "**Company**") refers to the announcements dated 8 March 2019, 4 July 2019, 8 August 2019, 4 September 2019, 16 October 2019, 31 October 2019, 8 November 2019 and 12 December 2019 regarding the Company's wholly-owned subsidiary, Sichuan Mianzhu Norwest Phosphate Chemical Co., Ltd. ("**Mianzhu Norwest**") and would like to provide an update. Mianzhu Norwest received a notice of claim (the "**Notice of Claim**") issued by the Mianzhu Municipal People's Court, which was filed by 20 former employees of Mianzhu Norwest who had resigned sometime in 2018. The claimants were claiming severance pay amounting to RMB1.844 million (approximately S\$0.373 million). Mianzhu Norwest attended the court hearing on 29 July 2019 and 6 August 2019.

On 4 September 2019, the Company received notification that the claim by the 20 former employees claim against Mianzhu Norwest has been dismissed, pursuant to the hearing in the Mianzhu Municipal People's Court and follow-up Mediation.

However, the plaintiffs reserved the right to appeal the decision, via the Deyang Intermediate Court. Mianzhu Municipal People's Court notified Mianzhu Norwest that an appeal had been issued by the exemployees and that, if Deyang Intermediate Court accepted the appeal, then Mianzhu Norwest may receive a follow-up Notice of Claim.

On 16 October 2019, the Company's wholly-owned subsidiary, Mianzhu Norwest received a notice of claim ("**16 October claim**") issued by Deyang Intermediate Court. This was filed by 12 out of 20 former employees of Mianzhu Norwest who had resigned sometime in 2018. Mianzhu Norwest attended the court hearing on 16 October but no judgement has been made at the hearing.

On 25 October 2019, the Company's wholly-owned subsidiary, Mianzhu Norwest received another notice of claim ("**25 October claim**") issued by Mianzhu Municipal People's Court. This was filed by 20 former employees of Mianzhu Norwest who had resigned sometime in 2018 and the amount claimed is RMB 0.87 million.

On 7 November 2019, the Company received notification that 11 out of 12 former employees' 16 October claim have been voluntarily withdrawn.

On 11 December 2019, the Company received notification relating the announcement dated 16 October 2019, the 12th former employee claim against Mianzhu Norwest has been dismissed pursuant to the hearing in the Deyang Intermediate Court.

## **UPDATE REGARDING THE 25 OCTOBER 2019 CLAIM**

With reference to the above-mentioned 25 October 2019 claim: On 18 December 2019, the Company received notification from our lawyers that the last of the 20 former employees' claim against Mianzhu Norwest have been voluntarily withdrawn.

On 19 December 2019, Mianzhu Norwest received another notice of claim issued by Mianzhu Labour Dispute Arbitration Committee. This was filed by the same 20 former employees of Mianzhu Norwest who had resigned sometime in 2018 and the amount claimed is RMB 0.29 million. We have sought advice from China legal counsel, who have opined that if the applicant has no new evidence, the case may be rejected by the arbitration commission, but noted that it is in Mianzhu Norwest's interest to remain actively involved in any formal hearing regarding this matter.
