On 17 July 2024, pursuant to an internal restructuring, InterBev Investment Limited ("IBIL") entered into a conditional share swap agreement ("SSA") with TCC Assets Limited ("TCCAL") pursuant to which (a) TCCAL shall transfer or procure the transfer to IBIL and/or its nominees 601,627,606 ordinary shares (the "F&N Transfer Shares") in the capital of Fraser and Neave, Limited ("F&N") (which represents approximately 41.30% of the total number of issued shares of F&N (excluding treasury shares) as at the date of the SSA, such shares, the "F&N Shares")); and (b) IBIL shall transfer to TCCAL and/or its nominees 1,130,041,272 ordinary shares in the capital of Frasers Property Limited ("FPL") (which represents approximately 28.78% of the total number of issued shares) as at the date of the SSA) (the "Proposed Share Swap").

Completion of the Proposed Share Swap has not taken place and is subject to the satisfaction of certain conditions as specified under the SSA. IBIL therefore has a deemed interest in the F&N Transfer Shares. Following the completion of the Proposed Share Swap, IBIL's percentage interest in the F&N Shares will increase from approximately 28.31% to approximately 69.61% (based on the total number of F&N Shares as at the date of the SSA).

IBIL is a wholly-owned subsidiary of International Beverage Holdings Limited ("IBHL"). Therefore, IBHL is deemed to be interested in all the F&N Shares in which IBIL has an interest.
