Pang Lim holds 50.0% of the shares of Jun Yuan Holdings Pte Ltd ("Jun Yuan Holdings"). Pursuant to Section 4 of the Securities and Futures Act ("SFA"), Pang Lim is deemed to have an interest in the 437,155,000 ordinary shares of the Company ("Shares") held by Jun Yuan Holdings.

Jun Yuan Holdings had on 17 July 2018, lent 18,000,000 Shares to DBS Bank Ltd. ("DBS") pursuant to a share lending agreement entered into between DBS and Jun Yuan Holdings. DBS is the stabilising manager in respect of the Offering (as defined in the prospectus of the Company dated 11 July 2018 (the "Prospectus")). In accordance with the terms of the share lending agreement, DBS may, inter alia, re-deliver such number of borrowed Shares to Jun Yuan Holdings within five (5) business days of the termination date, being the earlier of (i) the date falling 30 days from the date of commencement of trading of the Shares on the SGX-ST, and (ii) the date when DBS (or any of its affiliates or other persons acting on its behalf) has bought on the SGX-ST, an aggregate of 18,000,000 Shares, representing approximately 18.6% of the total Offering Shares (as defined in the Prospectus), to undertake stabilising actions.

In addition, pursuant to Section 133(4)(a) of the SFA, Pang Lim is deemed to have an interest in the 150,000 Shares held by his son, Pang Xue Ru, who is below the age of 21 years.
