

Dasin Retail Trust achieved 8.55% annualised distribution yield for 1H 2019

- Strengthening of foothold in the Guangdong-Hong Kong-Macau Greater Bay Area with the proposed acquisition of Doumen Metro Mall in Zhuhai City
- Strong Occupancy Rate of 98.4%

Singapore, 11 August 2019 – Dasin Retail Trust Management Pte. Ltd., the Trustee-Manager of Dasin Retail Trust ("DRT"), is pleased to announce DRT's results for the first half of 2019 (1H 2019). Based on an annualised 1H 2019 distribution per unit (DPU) and DRT's offering price per unit of S\$0.80, DRT's distribution yield is 8.55%.

Revenue for 1H 2019 was lower year-on-year mainly due to the impact of exchange rate differences between RMB against SGD as well as the asset enhancement initiative at Xiaolan Metro Mall which resulted in one-off reversal of accrued lease income previously calculated on a straight lining basis. The one-off reversal of accrued lease income from Xiaolan Metro Mall was mainly due to closure of about 2,500sqm of gross floor area in connection with the asset enhancement initiative to accommodate reputable tenants for a diverse tenant mix. Although net property income for 1H 2019 fluctuated somewhat year-on-year, the net property income margin for 1H 2019 was 81%, marginally higher than the estimated annualised net property income margin for the Trust of approximately 80%.

Mr. Zhang Zhencheng, Chairman of the Trustee-Manager of DRT, said, "On 30 June 2019, we announced the proposed acquisition of Doumen Metro Mall, which represents an opportunity for DRT to acquire a prime shopping mall in Doumen District in Zhuhai City. This will expand the Trust's presence beyond Zhongshan and increase its portfolio assets in the fast-developing Guangdong-Hong Kong-Macau Greater Bay Area ("Greater Bay Area"), thereby strengthening its foothold in the region².

Mr. Li Wen, CEO of the Trustee-Manager of DRT, said, "The proposed acquisition of Doumen Metro Mall is consistent with our strategy of acquiring quality income-producing real estate properties that will provide attractive cash flows and yields, to enhance returns to Unitholders and improve potential opportunities for future income and capital growth."

"We are also pleased to deliver a set of stable results for 1H 2019 and continue to offer an attractive distribution yield for our Unitholders. As at end June 2019, DRT's portfolio occupancy improved to 98.4% from 97.6% in 1Q 2019, with weighted lease to expiry at a healthy 3.9 years (by gross rental income) and 6.0 years (by net lettable area)."

Inbuilt Potential for Growth with Strong Pipeline

Dasin Retail Trust has a pipeline of 19 "Right of First Refusal" properties from the Sponsor, Zhongshan Dasin Real Estate Co., Ltd. These assets comprise 13 completed properties and 6 properties under development which are located in Zhongshan, Zhuhai, Shunde and Macau of the Guangdong-Hong Kong-Macau Greater Bay Area. The Trustee-Manager will undertake a prudent investment approach to inject these properties to enhance the portfolio of Dasin Retail Trust.
