### VARIATION TO BINDING TERM SHEET IN RELATION TO STRATEGIC PARTNERSHIP BETWEEN THE COMPANY AND ENGENEIC PTY LIMITED

*Unless otherwise defined or the context otherwise requires, all capitalised terms used herein bear the same meanings as in the Announcement (as defined below).*

The Board of Directors (the “**Board**” or “**Directors**”) of Singapore Institute of Advanced Medicine Holdings Ltd. (the “**Company**” and together with its subsidiaries, the “**Group**”) refers to the Company’s announcement dated 6 June 2024 (“**Announcement**”) relating to the binding Term Sheet between the Company and EnGeneIC Pty Limited (“**EnGeneIC**”) relating to the Parties’ intentions to explore a Strategic Partnership in relation to the manufacture and distribution of EDV-based Products and the development of EDV-based Theranostics.

The Board wishes to update that, subsequent to the Term Sheet, there have been positive developments in the application of EnGeneIC’s proprietary technology platform, EnGeneIC Dream Vector, resulting in potential changes to the scope of the Company’s involvement in the Strategic Partnership, including in the areas of pre-clinical and clinical work, and the manufacture and distribution of the EDV-based Products.

Consequently, the Parties have, by way of a variation letter dated 4 September 2024, mutually agreed with effect from 4 September 2024, on an extension of the period for Parties to work towards entering into a Definitive Agreement to 180 days commencing from the date of the Term Sheet, subject to any further extension agreed between the Parties. EnGeneIC will be required to comply with certain exclusivity obligations during such extended period.

Save for the above, all other terms and conditions of the Term Sheet remain unchanged.

The Company will keep shareholders updated on any material developments in relation to the Term Sheet by way of announcements as and when appropriate.
