## **ALLOTMENT AND ISSUE OF SHARES PURSUANT TO WARRANT EXERCISE**

The Board of Directors of Second Chance Properties Ltd (the "**Company**") and together with its subsidiaries, the "**Group**") wishes to announce that the number of issued ordinary shares of the Company has increased from 754,961,551 ordinary shares to 754,962,224 ordinary shares by way of the allotment and issuance of 673 new ordinary shares in the capital of the Company (the "**New Shares**") pursuant to the exercise of 673 warrants at the exercise price of S\$0.25 per share, on 28 December 2017. The New Shares rank pari passu in all respects with the existing shares of the Company. The New Shares are expected to be listed and quoted on the SGX-ST on 2 January 2018 and trading of the New Shares is expected to commence with effect from 9:00 a.m. on the same date.
