ACQUISITION OF ASSOCIATED COMPANIES

Singapore, 5 December 2019

The Board of Directors of Boustead Singapore Limited (the "Company") wishes to announce that J&M International Medical & Healthcare Limited ("J&M"), a 50%-owned associated company of its wholly owned subsidiary WhiteRock Incorporation Private Limited ("WRI"), has acquired a 100% interest in Beijing Echo Health Co., Ltd ("EchoHealth") and an 80% interest in IntellInnovation Health Technology (ChongQing) Co., Ltd ("IntellInnovation") (the "Acquisition") for an aggregate cash consideration of RMB29 million (approximately S\$5.6 million), comprising equity investment and working capital loan.

The Consideration was arrived at after arm's length negotiations on a willing buyer-willing seller basis. The Acquisition was funded from existing cash reserves.

WRI's core business of providing rehabilitation products and services have seen a shift from general rehabilitation to rehabilitation of chronic disease patients covering cardiac, stroke, diabetic, orthopaedic and frail conditions. This shift is in tandem with the growth in aging population and extension of the care continuum from acute to long term care comprising of community hospitals, nursing homes, day out patient care centres and home care.

EchoHealth serves as a company to provide rehabilitation services, training and education to healthcare facilities. It runs 3 rehabilitation centres currently and has conducted rehabilitation education courses for over 1,600 health professionals in 2019.

The acquisition of EchoHealth serves two primary purposes:

- diversifying the rehabilitation product distribution business into rehabilitation services, often times utilising the technologies to underpin the service offering, pivoting sales of products into a stream of service revenues; and
- bringing new treatment approaches to the China market through education, thereby deepening relationships with customers.

IntellInnovation is a start-up company that assembles and manufactures rehabilitation products. The aim is to partner some of WRI's principals to localise production in China to facilitate lower production costs, take advantage of local procurement preferences on the part of Chinese hospital customers.

Based on the management accounts of EchoHealth and IntellInnovation as at 30 November 2019, EchoHealth and IntellInnovation had aggregate net book value of RMB 1.7 million (approximately S\$330,000).

The Acquisition is not expected to have any material impact on the Boustead Group's earnings per share or net tangible assets per share for the financial year ending 31 March 2020.

None of the directors or controlling shareholders of the Company has any interest, direct or indirect, in the Acquisition.
