

## YANLORD LAND GROUP LIMITED

## ISSUE OF US\$350,000,000 6.75 PER CENT. SENIOR NOTES DUE 2023 BY YANLORD LAND (HK) CO., LIMITED

Yanlord Land Group Limited (the "Company") refers to the announcements dated 16 April 2018 and 19 April 2018 (the "Previous Announcements") made by the Company in connection with the issue of US\$350,000,000 6.75 per cent. senior notes due 2023 (the "Upsized Notes") by its wholly-owned subsidiary, Yanlord Land (HK) Co., Limited (the "Issuer"). Unless otherwise defined, all capitalised terms and references used in this announcement shall have the meanings ascribed to them in the Previous Announcements.

DBS Bank Ltd., The Hongkong and Shanghai Banking Corporation Limited and Standard Chartered Bank acted as the joint global coordinators, joint bookrunners and joint lead managers in relation to the Upsized Notes.

The Upsized Notes have been offered by the Issuer pursuant to exemptions invoked under Sections 274 and/or 275 of the Securities and Futures Act, Chapter 289 of Singapore and will only be offered and sold outside the United States in offshore transactions in reliance on Regulation S under the U.S. Securities Act of 1933, as amended.

The Upsized Notes were issued by the Issuer at an issue price of 100 per cent. of their principal amount and in minimum denominations of US\$200,000 and integral multiples of US\$1,000 in excess thereof. The Upsized Notes have been rated "BB-" by Standard & Poor's Ratings Services and "Ba3" by Moody's Investors Service, Inc., and will bear interest at a fixed rate of 6.75 per cent. per annum payable semi-annually in arrears. The Upsized Notes will mature on 23 April 2023.

The net proceeds from the offering of the Upsized Notes are approximately US\$345.6 million, after deducting underwriting discounts and commissions and estimated offering expenses payable by the Company and its subsidiaries. The Company and its subsidiaries intend to use the net proceeds from the offering for project development and acquisition and general corporate purposes.

Approval in-principle has been received from the Singapore Exchange Securities Trading Limited (the "SGX-ST") for the listing and quotation of the Upsized Notes on the SGX-ST. The SGX-ST assumes no responsibility for the correctness of any of the statements made, opinions expressed or reports contained herein. Approval in-principle from, admission to the Official List of, and the listing and quotation of the Upsized Notes on, the SGX-ST are not to be taken as an indication of the merits of the Issuer, the Company, the subsidiary guarantors, the Company's associated companies or the Upsized Notes. The Upsized Notes are expected to be listed on the SGX-ST on 24 April 2018.

A controlling shareholder of the Company has been allocated 14.3 per cent. of the issue of the Upsized Notes.
