

ALLOTMENT AND ISSUANCE OF SHARES PURSUANT TO WARRANT EXERCISE

The Board of Directors (the "**Board**") of ValueMax Group Limited (the "**Company**") wishes to announce the number of issued ordinary shares of the Company has increased from 868,213,885 ordinary shares (exclusive of 100,000 treasury shares) to 868,447,321 ordinary shares by way of allotment and issuance 233,436 warrants at the exercise price of S\$0.36 each, on 17 January 2025.
