("DBS Bank") pursuant to a private placement ("Transaction").

The filing of Temasek's deemed interest arises from the interest held by DBS Group Holdings Ltd ("DBSH"):

- (i) DBS Bank is a wholly owned subsidiary of DBSH and has a direct interest in in 6.61% of voting units of the Listed Issuer.
- (ii) Temasek has a more than 20% interest in DBSH, an independently managed Temasek portfolio company.
