Following completion of the cancellation of Jardine Strategic’s 59% shareholding in JMH on 18 May 2022, JMH was notified on 18 May 2022 by Butterfield Trust (Bermuda) Limited, in its capacity as the trustee of family trusts, that its aggregate interest in JMH had increased from 5.35% to 13.25% of the voting rights.
