ESR-REIT Management (S) Limited ("ERM") holds 220,204,281 ESR-REIT units and the property manager of ESR-REIT, ESR Property Services Pte. Ltd. ("EPS"), holds 45,961,181 ESR-REIT units. Both ERM and EPS are indirect subsidiaries of e-Shang Infinity Cayman Limited. Therefore, e-Shang Infinity Cayman Limited is deemed to be interested in the 266,165,462 ESR-REIT units held by ERM and EPS. e-Shang Infinity Cayman Limited directly holds 971,655,245 ESR-REIT units and is also a subsidiary of e-Shang Jupiter Cayman Limited, which then holds a total deemed interests of 1,237,820,707 ESR-REIT units and is itself a subsidiary of ESR Group Limited. LOGOS Units No. 1 Ltd directly holds 448,429,218 ESR-REIT units and is an indirect subsidiary of ESR Group Limited. Thus, overall, ESR Group Limited has deemed interests in the 1,686,249,925 units held indirectly by companies in which it is entitled to exercise or control the exercise of not less than 20% of the votes attached to the voting units thereof.
