Ltd. (the "Offeror") in relation to the voluntary conditional cash offer (the "Offer") for all the Shares, other than any Shares held in treasury and those Shares held, directly or indirectly, by the Offeror as at the date of the Offer.

Pursuant to the Consortium Arrangements and with respect to Item 6 of Part III:

(a) the total cash consideration that would be payable by the Offeror to Mr. Lim Puay Koon for accepting the Offer in respect of the 7,240,500 Shares held by Mr. Lim Puay Koon (the "Relevant LPK Proceeds") will be regarded as an interest-free shareholder's loan extended by Mr. Lim Puay Koon to the Offeror in accordance with the terms of the Consortium Agreement; and

(b) following the completion of the Transaction, (i) a portion of the Relevant LPK Proceeds will be capitalised into new ordinary shares in the Offeror (the "Offeror Shares") to be allotted and issued to Mr. Lim Puay Koon; and (ii) the consideration payable by Mr. Lim Puay Koon for the subscription of such new Offeror Shares shall be set-off against such amount of Relevant LPK Proceeds to be capitalised, and the balance amount of Relevant LPK Proceeds shall remain as an interest-free shareholder loan extended by Mr. Lim Puay Koon to the Offeror.
