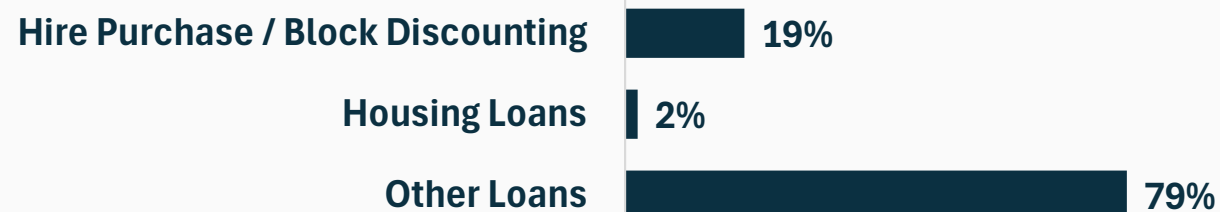

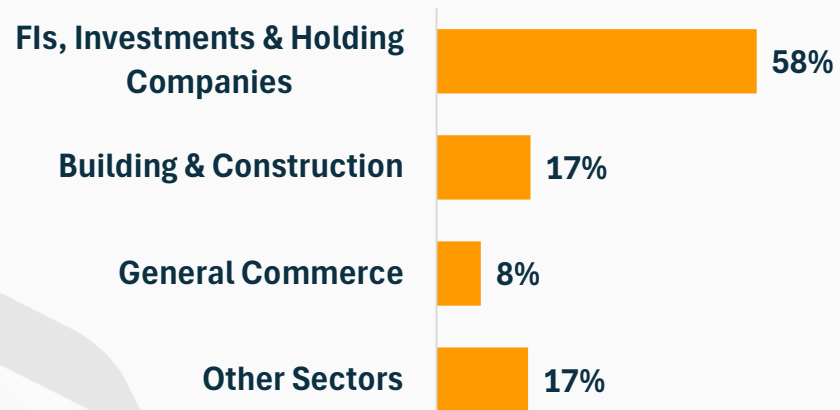

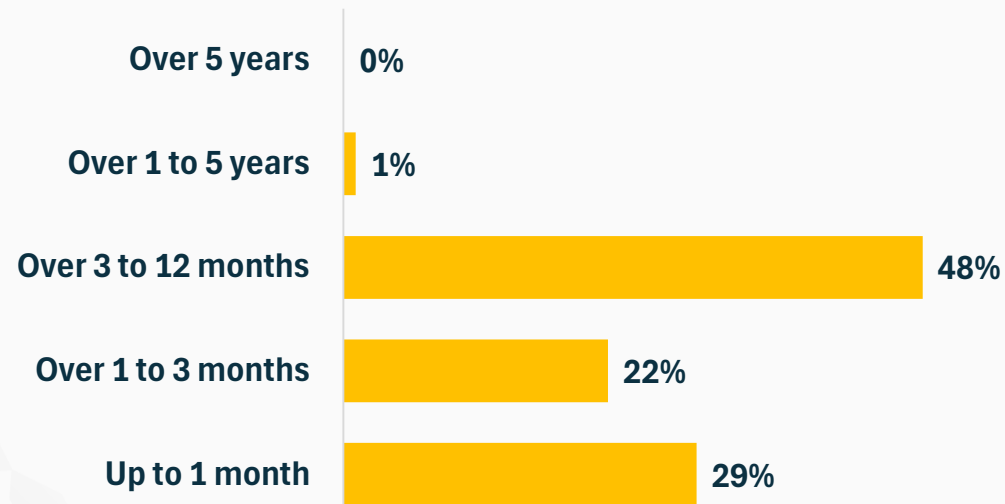

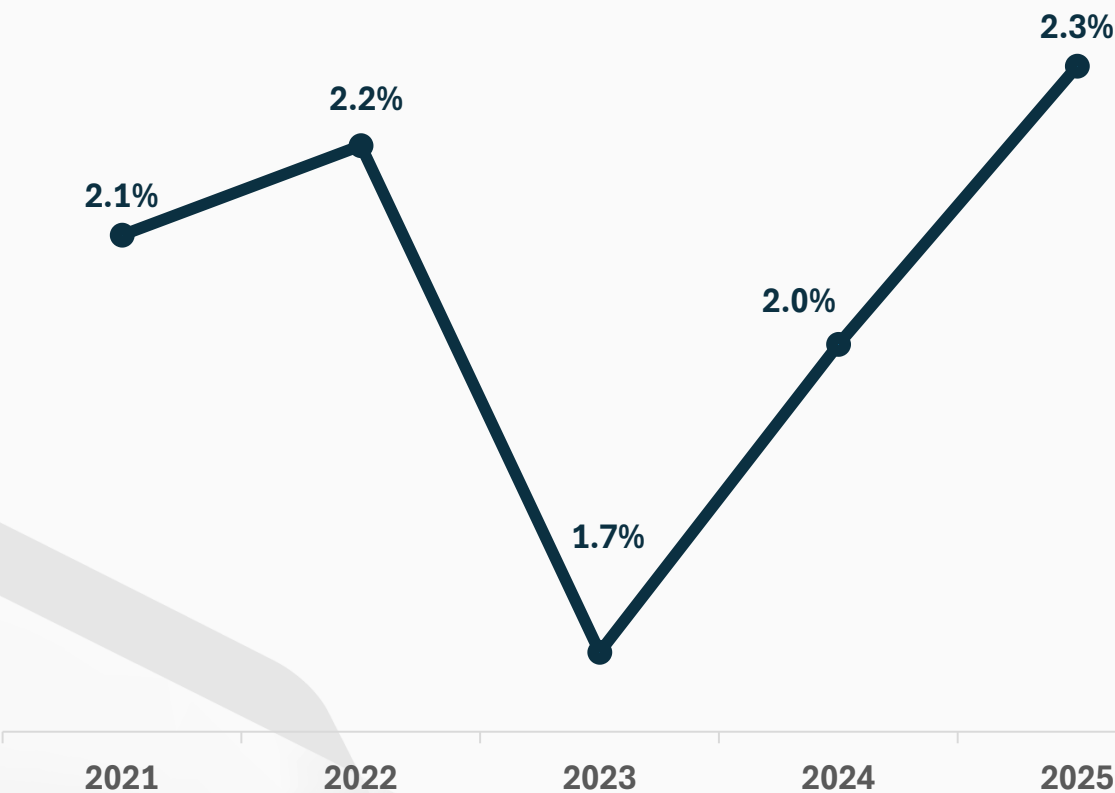

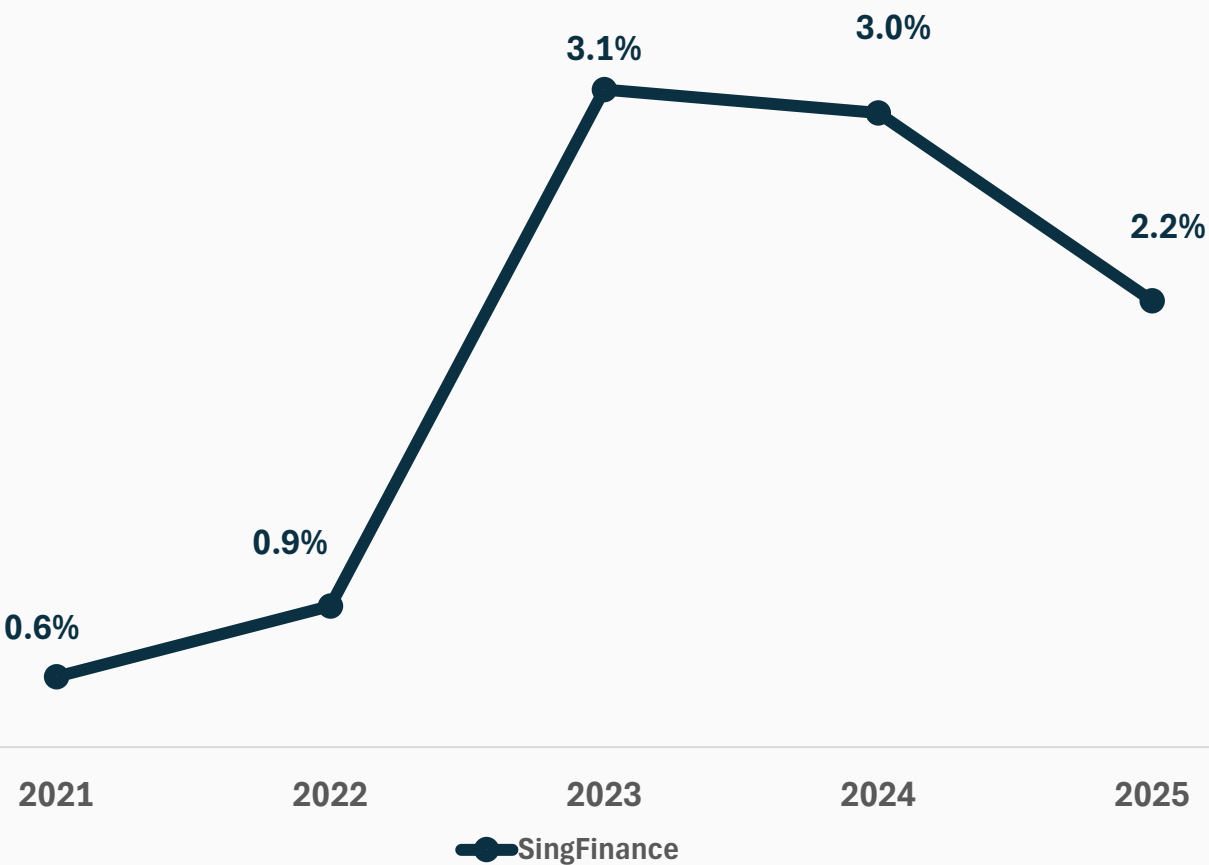
Net Interest Margin

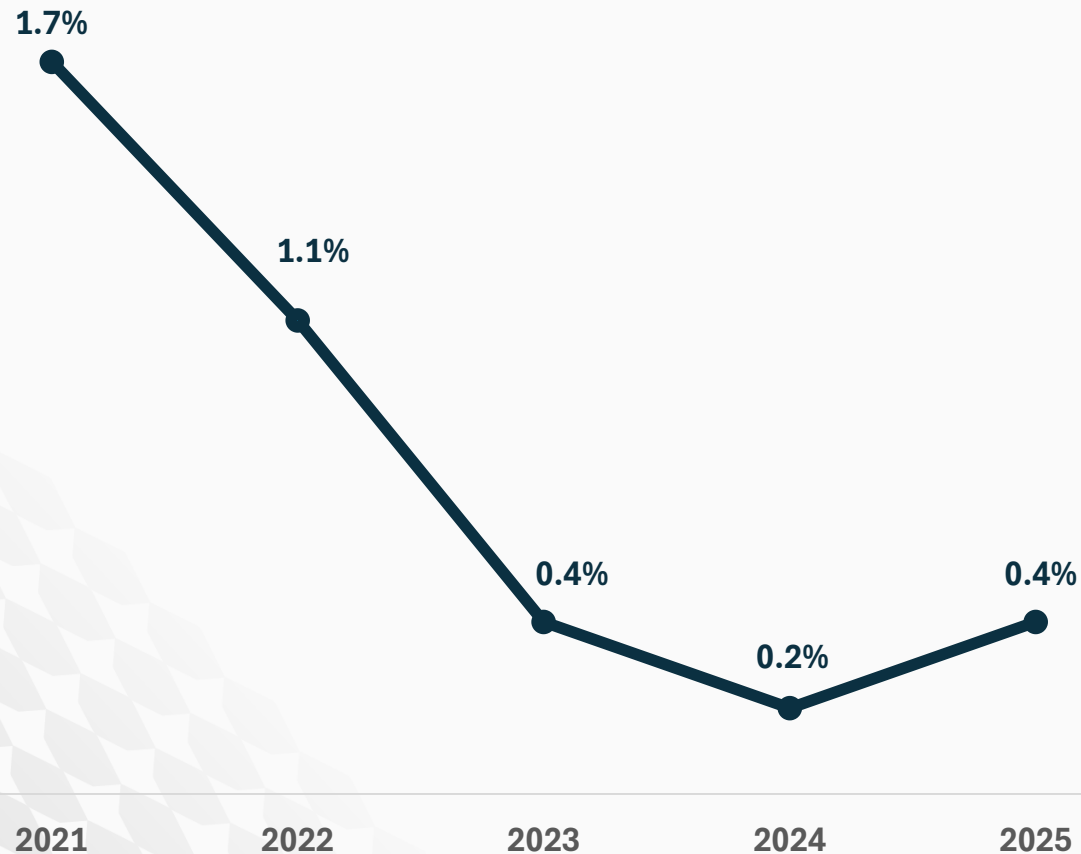


Asset Quality & Cost Management

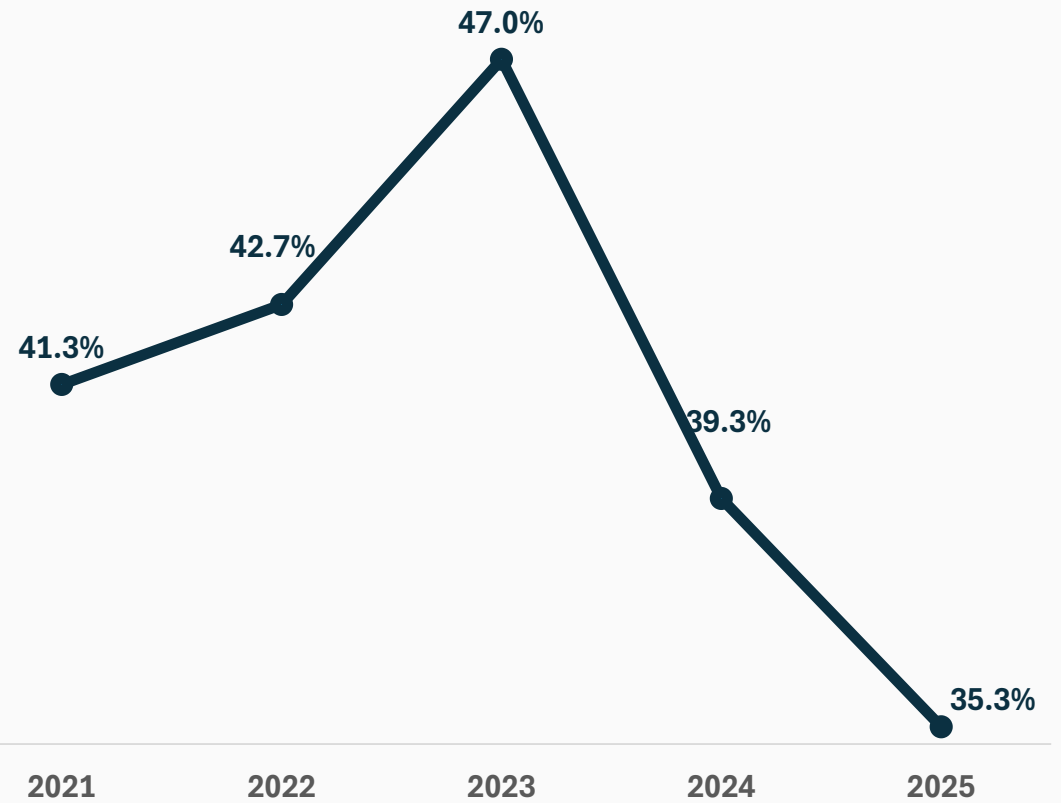
Non-performing Loans Ratio

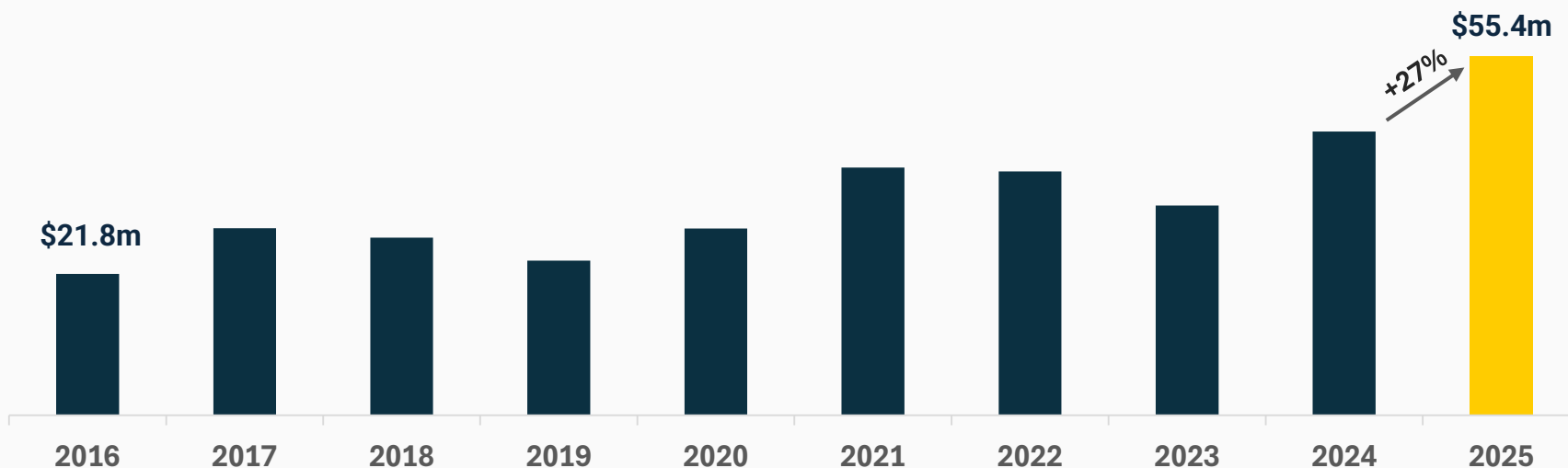

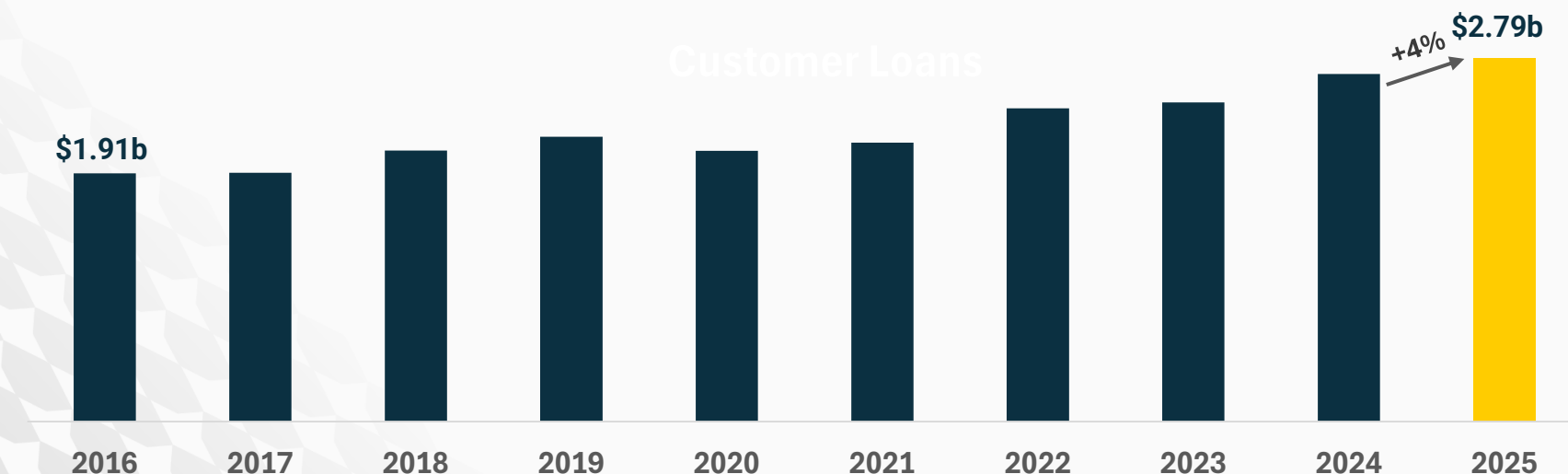
