Mr Tan has been informed by DBS Nominees Pte Ltd that he did not receive the scrip dividend in respect of the final one-tier tax-exempt dividend for the financial year ended 31 December 2023. Accordingly, the opening balance disclosed in his notification dated 26 September 2024 (the "26 September 2024 Notification") should be 60,000 shares instead of 62,400 shares.

Consequently, his entitlement to the scrip dividend in respect of the interim one-tier tax-exempt dividend for the financial year ending 31 December 2024 should be 1,764 shares instead of 1,835 shares.
