### 1. INTRODUCTION

The Board wishes to announce that Tianjin Shin Poong Pharmaceutical Co., Ltd. ("**Tianjin Shin Poong**"), a subsidiary of Tianjin Zhong Xin Pharmaceutical Group Corporation Limited (the "**Company**"), has recently obtained a certification of good manufacturing practice for pharmaceutical products from the Tianjin Market and Quality Supervision Administration (the "**Drug GMP Certification**"). ### 1.2 Background information about Tianjin Shin Poong and the products:

Tianjin Shin Poong is a joint venture company incorporated by Tianjin Zhong Xin Pharmaceutical Group Corporation and Korea Shin Poong Pharmaceutical Co., Ltd in 1995, which specialises in the production of cephalosporins.

The company is located at No.8 Mu Ning Road, Economic & Technological Development Zone, Tianjin, near the Bohai coast, which covers an area of about 2.3 million square meters. The asset value and net asset value of the fixed assets of the company are approximately RMB122.59 million and RMB72.62 million respectively. Tianjin Shin Poong is a company which is primarily engaged in the development, manufacture, and sales of medicine, and has also obtained approval for the manufacture of 27 different products, of which 12 are approved for annual production. Tianjin Shin Poong currently has 108 employees, including 53 with professional and technical roles.

Two of the products which are subpackaged by Tianjin Shin Poong are Ceftezole Sodium for

Injection and Cefazedone Sodium for Injection. Ceftezole Sodium for Injection is used in the treatment of sepsis, pneumonia, bronchitis, bronchiectasis (infection), secondary infection of chronic respiratory system diseases, lung abscess, peritonitis, pyelonephritis, cystitis and urethritis.

Cefazedone Sodium for Injection is used for its antibacterial properties, particularly against gram positive bacteria such as staphylococcus aureus, coagulase negative staphylococcus, streptococcus pneumoniae, beta hemolytic streptococcus, etc. It has a similar effect as Cefazolin against gram negative bacteria. It is usually used in the treatment of respiratory system, digestive system (biliary tract infection, peritonitis), urinary system, reproductive system, skin and soft tissue, bone and joint infection caused by sensitive bacteria, it also can be used as preventative medication before surgery.
