### HALCYON AGRI REPORTS US\$781M REVENUE FOR 9M 2015

- Revenue of US\$781m on sales volume of 510,812 tonnes

**Singapore, 4 November 2015** Natural rubber supply chain manager Halcyon Agri Corporation Limited today announced strong results for the third quarter 2015.

Halcyon Agri Executive Chairman and CEO Robert Meyer commented: "We've continued our earnings momentum into the third quarter, delivering strong sales, earnings and operating cash flow. Our processing and distribution businesses both delivered strong results, each accounting for more than 100,000 tonnes of natural rubber sales in the quarter". The Group's results were achieved against a backdrop of continued volatility in the traded market prices for natural rubber, which retreated further in the third quarter.

In the third quarter, Halcyon Agri devoted considerable resources to readying its facilities and staff for the launch of its HEVEAPRO brand natural rubber which is produced to specific criteria regarding quality, environment health & safety, social responsibility and security. The Group launched HEVEAPRO on 1 October 2015. Mr Meyer remarked "We've been pleased with the response to HEVEAPRO so far and are encouraged to see our employees and customers share our determination to see quality natural rubber produced sustainably".
