REIT Manager is a wholly owned subsidiary of UIB Holdings Limited ("UIBHL"). UIBHL is approximately 20% held by BP-Unity Pte. Ltd., which is approximately 83.7% held by BP-Real Estate Investments Pte. Ltd. ("BPREI"). BPREI is wholly-owned by Boustead Projects Limited ("BPL"), which in turn is approximately 99% owned by Boustead Singapore Limited ("BSL"). Wong Fong Fui owns approximately 44% in BSL.

By virtue of this, each of BPL, BSL and Wong Fong Fui has a deemed interest in all the units in UIB REIT which BPREI and UIBHL holds under Section 4 of the Securities and Futures Act 2001 of Singapore.
