## **Sysma Holdings adds on S\$127 million order book with new S\$5.85 million contract win**

- **New addition and alteration contract at Gallop Road for an established private owner**

**Singapore, 9 November 2015** – Sysma Holdings Limited (“Sysma Holdings” and together with its subsidiaries, the “Group”), an established construction company with diversification into real estate development, today announced that its wholly-owned subsidiary, Sysma Construction Pte. Ltd. (“Sysma Construction”) has secured a new contract with an established private owner to handle addition and alteration works for two properties at Gallop Road (the “Contract”).

Valued at S\$5.85 million, the Contract involves two units of two-storey detached dwelling houses with basements and will commence in November this year for a period of 12 months.

Mr Sin Soon Teng, Executive Chairman and Group Chief Executive Officer of Sysma Holdings, said, “This latest contract adds on our existing order book which stands at approximately S\$127 million<sup>1</sup>. We believe the demand for landed properties continues to be resilient, despite the muted real estate market. The limited supply of such homes, particularly in district 9, 10 and 11, makes it appealing for long-term investors. Our market reputation as a trusted builder of good class bungalows and high-end landed properties has helped maintain our strong customer base and robust order book.”
