United Overseas Bank Limited (the "Company"), wishes to announce that it intends to issue EUR850,000,000 2.718 per cent. Covered Bonds due 2030 (the "Covered Bonds"). The Covered Bonds will be issued as the thirteenth series under the US\$15 billion Global Covered Bond Programme (the "Covered Bond Programme"). United Overseas Bank Limited, BNP PARIBAS, The Hongkong and Shanghai Banking Corporation Limited, Singapore Branch, Landesbank Hessen-Thüringen Girozentrale and Société Générale have been appointed as joint lead managers for the Covered Bonds.

The Company is pleased to announce that it has priced the offering of the Covered Bonds and the principal terms of the Covered Bonds are as follows:

Instrument: EUR Fixed Rate Covered Bonds

Issue Price: 100% of the principal amount of the Covered Bonds

Ratings: The Covered Bonds are expected to be rated Aaa by Moody's

Investors Service and AAA by Standard & Poor's Rating Services

Maturity Date: It is intended that the Covered Bonds will mature on 1 December
