As announced by the Company on 4 May 2018, the investigations relate to an offence under the Securities and Futures Act (Chapter 289, 2006 Revised Edition) ("SFA") pursuant to the provisions of the Criminal Procedure Code. However, the Commercial Affairs Department ("CAD") has not disclosed to the Company any further details on the investigations.

SGX's Query #2:

Please state the section(s) of the Securities and Futures Act (Cap. 289) which the possible offence(s) relate to.

Company's Response:

The potential contravention relates to Section 197 of the SFA. However, no charges have been brought as yet since investigations are still pending.

SGX's Query #3:

Please clarify whether the investigation is in relation to the shares, business activities and/or operations of the Group.

Company's Response:

The investigation is in relation to the shares of the Company.

SGX's Query #4:

We note that the Company has stated in the 8 May 2018 Announcement that Ms. Ho Hui Min, the Chief Financial Officer and Head, Corporate of the Company, has provided a bond to report back to the Commercial Affairs Department (the "CAD") to assist in further investigations. Please clarify whether any of the other named individuals mentioned in the Announcements have posted bail / provided a bond to the CAD.

Company's Response:

No other named individuals mentioned in the Announcements have posted bail and/or provided a bond to the CAD. However, Ms. Michelle Ibanez Gonzales, an Administrative Accounts Executive of Kian Ho Pte Ltd ("KHPL"), has been requested to post a bond on 11 May 2018.

SGX's Query #5:

Please also clarify whether any of the named individuals mentioned in the Announcements have had their passports impounded by the CAD.

The following individuals mentioned in the Announcements have had their passports impounded by the CAD:

SGX's Query #6:

We also note that the Company has stated in its 8 May 2018 Announcement that "certain staff and exstaff of the Group were also interviewed by the CAD in relation to its investigations on 2 May 2018". Please provide information on these individuals and state whether they have posted bail / provided a bond to the CAD or have had their passports impounded by the CAD.

Company's Response:

These individuals include:

- 1. Mr. Teo Teng Ho, a former Consultant of the Company and brother of Mr. Teo Teng Beng, was interviewed by the CAD to assist in the investigations on 2 May 2018;
- 2. Ms. Michelle Ibanez Gonzales, an Administrative Accounts Executive of KHPL, was interviewed by the CAD to assist in the investigations on 2 May 2018, 3 May 2018 and 4 May 2018;
- 3. Ms. Lee Suang Hee, an Assistant Manager, Local Retail of KHPL, was interviewed by the CAD to assist in the investigations on 2 May 2018;
