### **NOTICE OF ANNUAL GENERAL MEETING**

NOTICE IS HEREBY GIVEN that the Annual General Meeting ("Meeting") of Sakae Holdings Ltd. (the "Company") will be held at 28 Tai Seng Street, Sakae Building, Level 7, Singapore 534106, on Monday, 29 October 2018 at 3.00 p.m. for the following purposes:

#### **Ordinary Business**

- To receive and adopt the Directors' Statements and Audited Financial Statements of the Company for the financial period from 1 January 2017 to 30 June 2018 together with the Auditors' Report thereon. (Resolution 1)
- To re-elect the Mr Chan Wing Leong retiring by rotation pursuant to Article 91 of the Company's Articles of Association and who, being (Resolution 2) eligible, offers himself for re-election. [See Explanatory Note (i)] Mr Chan Wing Leong will, upon re-election as a Director of the Company, remain as Chairman of the Remuneration Committee and member of the Audit Committee and Nominating Committee. He will be considered independent for the purposes of Rule 704(8) of the Listing Manual of the Singapore Exchange Securities Trading Limited
- To note the retirement of Mr Lim Chee Yong. [See Explanatory Note (ii)] 3.
- To approve the payment of Directors' fees of S\$150,000 (FY2016: S\$100,000) for the financial year ended 30 June 2018.

(Resolution 3)

To re-appoint Messrs Deloitte & Touche LLP as the Company's Auditors and to authorise the Directors to fix their remuneration. (Resolution 4)

To transact any other ordinary business which may properly be transacted at an Annual General Meeting. 6.

#### Special Business

To consider and if thought fit, to pass the following resolution as Ordinary Resolution, with or without any modifications:

- - "That pursuant to Section 161 of the Companies Act, Cap. 50 and Rule 806(2) of the Listing Manual of the Singapore Exchange Securities Trading Limited (the "SGX-ST"), authority be and is hereby given to the Directors of the Company to:issue shares in the capital of the Company ("shares") whether by way of rights, bonus or otherwise; and/or
    - - make or grant offers, agreements or options (collectively, "Instruments") that might or would require shares to be issued, including but not limited to the creation and issue of (as well as adjustments to) warrants, debentures or other instruments convertible into shares,

at any time and upon such terms and conditions and for such purposes and to such persons as the Directors may in their absolute discretion deem fit; and

- (notwithstanding the authority conferred by this Resolution may have ceased to be in force) issue shares in pursuance of any Instrument made or granted by the Directors while this Resolution was in force, provided that: the aggregate number of shares to be issued pursuant to this Resolution (including shares to be issued in pursuance of
  - Instruments made or granted pursuant to this Resolution) does not exceed fifty per cent. (50%) of the Company's total number of issued shares [excluding treasury shares and shares (if any) held by a subsidiary] (as calculated in accordance with sub-paragraph (2) below), of which the aggregate number of shares to be issued other than on a pro-rata basis to existing shareholders of the Company (including shares to be issued in pursuance of Instruments made or granted pursuant to this Resolution) does not exceed twenty per cent. (20%) of the Company's total number of issued shares [excluding treasury shares and shares (if any) held by a subsidiary] (as calculated in accordance with sub-paragraph (2) below). Unless prior shareholder approval is required under the Listing Manual of the SGX-ST, an issue of treasury shares will not require further shareholder approval, and will not be included in the aforementioned limits. (subject to such manner of calculation as may be prescribed by the SGX-ST) for the purpose of determining the aggregate
  - number of shares that may be issued under sub-paragraph (1) above, the total number of issued shares [excluding treasury shares and shares (if any) held by a subsidiary] is based on the Company's total number of issued shares excluding treasury shares and shares (if any) held by a subsidiary at the time this Resolution is passed, after adjusting for:
    - new shares arising from the conversion or exercise of any convertible securities or share options or vesting of share awards which are outstanding or subsisting at the time this Resolution is passed; and
      - any subsequent bonus issue, consolidation or subdivision of shares; in exercising the authority conferred by this Resolution, the Company shall comply with the provisions of the Listing Manual
  - (3) of the SGX-ST for the time being in force (unless such compliance has been waived by the SGX-ST) and the Articles of Association for the time being of the Company; and
  - (unless revoked or varied by the Company in general meeting) the authority conferred by this Resolution shall continue in force until the conclusion of the next Annual General Meeting of the Company or the date by which the next Annual General Meeting of the Company is required by law to be held, whichever is the earlier." (Resolution 5) [See Explanatory Note (iii)]

- Mr Chan Wing Leong has no relationship (including immediate family relationships) with the other Directors, the Company or its 10% shareholders (ii) In accordance with Article 91 of the Company's Articles of Association of the Company, Mr Lim Chee Yong retires from office and will
- not be seeking re-election. Accordingly, Mr Lim Chee Yong will cease as a Chairman of Audit Committee and Nominating Committee and a member of the Remuneration Committee. (iii) Ordinary Resolution 5 is to empower the Directors from the date of the above Meeting until the date of the next Annual General
- Meeting, to allot and issue shares and convertible securities in the Company. The aggregate number of shares (including any shares issued pursuant to the convertible securities) which the Directors may allot and issue under this Resolution will not exceed fifty per cent. (50%) of the Company's total number of issued shares excluding treasury shares and shares (if any) held by a subsidiary of the Company. For issues of shares other than on a pro rata basis to all shareholders, the aggregate number of shares to be issued will not exceed twenty per cent. (20%) of Company's total number of issued shares excluding treasury shares and shares (if any) held by a subsidiary of the Company. This authority will, unless previously revoked or varied at a general meeting, expire at the next Annual General Meeting of the Company or the date by which the next Annual General Meeting of the Company is required by law to be held, whichever is earlier. However, notwithstanding the cessation of this authority, the Directors are empowered to issue shares pursuant to any Instrument made or granted under this authority.

# Notes:

- A member entitled to attend and vote at the Meeting is entitled to appoint one or two proxies to attend and vote in his stead, subject to note 3 below. A proxy need not be a member of the Company. Where a member appoints more than one proxy, the appointments shall be invalid unless he specifies the proportion of his holding
- (expressed as a percentage of the whole) to be represented by each proxy. A member who is a relevant intermediary entitled to attend the Meeting and vote is entitled to appoint more than two proxies to attend 3.
- and vote instead of the member, but each proxy must be appointed to exercise the rights attached to a different share or shares held the number of shares in relation to which each proxy has been appointed. "Relevant intermediary" means:
  - a banking corporation licensed under the Banking Act, Chapter 19 of Singapore, or a wholly-owned subsidiary of such a banking a) corporation, whose business includes the provision of nominee services and who holds shares in that capacity;
    - a person holding a capital markets services licence to provide custodial services for securities under the Securities and Futures Act, Chapter 289 of Singapore, and who holds shares in that capacity; or the Central Provident Fund Board established by the Central Provident Fund Act, Chapter 36 of Singapore, in respect of shares
  - c) purchased under the subsidiary legislation made under that Act providing for the making of investments from the contributions and interest standing to the credit of members of the Central Provident Fund, if the Board holds those shares in the capacity of an intermediary pursuant to or in accordance with that subsidiary legislation.
- The instrument appointing a proxy or proxies must be under the hand of the appointor or of his attorney duly authorised in writing. 4. Where the instrument appointing a proxy or proxies is executed by a corporation, it must be executed either under its common seal or under the hand of its attorney or a duly authorised officer.
