

**ANNUAL GENERAL MEETING AND EXTRAORDINARY GENERAL MEETING OF  
KEPPEL PACIFIC OAK US REIT TO BE HELD ON 17 APRIL 2025**

1. **Background:** Keppel Pacific Oak US REIT Management Pte. Ltd., as manager of Keppel Pacific Oak US REIT (the "**Manager**"), refers to:

- (a) the Notice of Annual General Meeting ("**Notice of AGM**") and the Notice of Extraordinary General Meeting ("**Notice of EGM**"), each dated 26 March 2025, which are published on Keppel Pacific Oak US REIT's website at <https://www.koreusreit.com/investor-relations/agm-egm/> and on SGXNet; and
- (b) Practice Note 7.5 (General Meetings) of the Singapore Exchange Listing Rules (Mainboard) as amended by the Singapore Exchange Regulation, effective 1 July 2023, which provides guidance on, *inter alia*, the conduct of general meetings from 1 July 2023.

2. **Date, time and place of Annual General Meeting and Extraordinary General Meeting:** The Manager wishes to announce that:

- (a) the Annual General Meeting of Keppel Pacific Oak US REIT ("**AGM**") will be held, in a wholly physical format, at Suntec Singapore Convention and Exhibition Centre, Nicoll 1-2, Level 3, 1 Raffles Boulevard Suntec City, Singapore 039593 (the "**Venue**") on **Thursday, 17 April 2025 at 2.00 p.m. (Singapore time)**; and
- (b) the Extraordinary General Meeting of Keppel Pacific Oak US REIT ("**EGM**") will be held, in a wholly physical format, at the Venue, on the same day, on **Thursday, 17 April 2025 at 3.00 p.m. (Singapore time) or immediately after the conclusion or adjournment (as the case may be) of the AGM.**

**There will be no option for unitholders of Keppel Pacific Oak US REIT ("Unitholders") to participate virtually.**

3. **Notice of Meetings, Proxy Form and Related Documents:** Printed copies of the Notice of AGM, the Notice of EGM, and the respective proxy forms will be sent to Unitholders.

In line with Keppel Pacific Oak US REIT's drive towards sustainable development, the annual report for the financial year ended 31 December 2024 ("**Annual Report 2024**"), the Appendix to the Notice of AGM ("**Appendix**") and the Circular in respect of the EGM ("**Circular**") has been issued by the Manager electronically and Unitholders may view and download the digital version of these documents, as well as the Notice of AGM, the Notice of EGM, and the respective proxy forms from Keppel Pacific Oak US REIT's website at <https://www.koreusreit.com> and on SGXNet from the date of this announcement.

- (a) To access the Annual Report 2024, click on "Quick Downloads" under the Investor Relations tab and click on the relevant link to download.
- (b) To access the Notice of AGM, Notice of EGM, the Appendix and the respective proxy forms, click on "AGM & EGM Information" under the Investor Relations tab and click on the relevant link to download.

A Unitholder who still wishes to receive printed copies of the Annual Report 2024 and Appendix for this year may complete the request form enclosed with the letter to Unitholders and return it to the Manager by no later than **7 April 2025**. All previous requests, including any standing instructions for printed annual reports, will be disregarded.

4. **Arrangements for participation in the AGM and/or EGM:** Unitholders, including SRS investors, may participate in the AGM and/or EGM by:

- (a) attending the AGM and/or EGM in person;
- (b) submitting questions to the Manager in advance of, or at, the AGM and/or EGM; and/or
- (c) voting at the AGM and/or EGM (i) themselves; or (ii) through duly appointed proxy(ies).<sup>1</sup>

Details of the steps for registration, submission of questions and voting at the AGM and/or EGM by Unitholders, including SRS investors, are set out in the **Annex** to this announcement. In particular, SRS investors who wish to request their SRS operators to appoint the Chairman as proxy in respect of the units in Keppel Pacific Oak US REIT ("Units") held by such SRS operators on their behalf should approach his/her respective SRS operators to submit their votes by **5.00 p.m. on 7 April 2025 (in respect of both the AGM and EGM)**.

5. **Persons who hold Units through relevant intermediaries:** Persons who hold Units through relevant intermediaries (other than SRS investors) and who wish to participate in the AGM and/or EGM by (a) attending the AGM and/or EGM in person; (b) submitting questions to the Manager in advance of, or at, the AGM and/or EGM; and/or (c) voting at the AGM and/or EGM (i) themselves; or (ii) by appointing the Chairman as proxy in respect of the Units held by such relevant intermediary on their behalf, **should contact the relevant intermediary through which they hold such Units as soon as possible, and by no later than 5.00 p.m. on 7 April 2025 (in respect of both the AGM and EGM), in order for the necessary arrangements to be made for their participation in the AGM and/or EGM.**

A "relevant intermediary" means:

- (a) a banking corporation licensed under the Banking Act 1970 of Singapore, or a wholly-owned subsidiary of such a banking corporation, whose business includes the provision of nominee services and who holds Units in that capacity; or
- (b) a person holding a capital markets services licence to provide custodial services for securities under the Securities and Futures Act 2001 of Singapore, and who holds Units in that capacity; or

		<p>event, the Manager reserves the right to refuse to admit any person or persons appointed under the proxy form to the AGM and/or EGM.</p> <p><b>SRS investors:</b></p> <p>(a) may vote at the AGM and/or EGM if they are appointed as a proxy by their respective SRS operators, and should contact their respective SRS operators if they have any queries regarding their appointment as proxy; or</p> <p>(b) may appoint the Chairman as proxy to vote on their behalf at the AGM and/or EGM, in which case they should approach their respective SRS operators to submit their votes by <b>5.00 p.m. (in respect of both the AGM and EGM) on 7 April 2025.</b></p>
