The change in Temasek's deemed interest is due to payment of management fee by way of issue of units to Keppel Capital Investment Holdings Pte. Ltd. ("KCIHPL"). KCIHPL is an indirect subsidiary of Keppel Corporation Ltd ("KCL"). Temasek's deemed interest in the units arises from the aggregation of deemed interests of KCL and DBS Group Holdings Ltd ("DBSH"). KCL and DBSH are independently managed Temasek portfolio companies.
