Tan Sri Cheng Heng Jem ("Tan Sri") is deemed to be interested in 25,251,000 ordinary shares comprising 16,668,000 ordinary shares deemed held by Lion Corporation Berhad ("LCB") and 8,450,000 ordinary shares held by Lion Enterprise (Kuala Lumpur) Sdn Bhd, 100,000 ordinary shares held by Lion AMB Resources Berhad and 33,000 ordinary shares held by Lion Industries Corporation Berhad.

LCB is deemed to be interested in 16,668,000 ordinary shares deemed held by ACB Resources Berhad ("ACB").

ACB is deemed to be interested in 16,668,000 ordinary shares comprising 5,583,000 ordinary shares deemed held by Akurjaya Sdn Bhd ("Akurjaya"), 7,810,000 ordinary shares deemed held by Angkasa Marketing (Singapore) Pte Ltd ("Angkasa Marketing") and 3,275,000 ordinary shares held by Umatrac Enterprises Sdn Bhd.
