FPL therefore has a deemed interest in the units in FCOT in which each of FCOAM and FPCTH has an interest, by virtue of Section 4 of the Securities and Futures Act (Chapter 289) of Singapore ("SFA").

RM together with Maxtop Management Corp. ("MMC") and Golden Capital (Singapore) Limited ("GC") collectively holds a greater than 20% interest in Thai Beverage Public Company Limited ("ThaiBev");
