
ACQUISITION OF ADDITIONAL SHARES IN THONG SIEK GLOBAL PTE. LTD.

The board of directors (the “**Board**” or the “**Directors**”) of Neo Group Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) wishes to announce that it has acquired today, an additional 30,000 ordinary shares of Thong Siek Global Pte. Ltd. (“**TSG**” and together with its subsidiaries, the “**TSG Group**”) (“**Sale Shares**”) representing as at the date of this announcement, approximately 2.33% equity interest in TSG, from Ms. Lim Siow Yin (“**Vendor**”) for a cash consideration of S\$350,000 (“**Purchase Consideration**”) (“**Acquisition**”).

The Purchase Consideration will be paid by way of cheque to the Vendor on or before 30 April 2020 and was based on, *inter alia*, the initial valuation at which the Company invested into TSG, the historical results and net book value of the TSG Group. No independent valuation was conducted on TSG Group.

As the applicable relative figures in relation to the Acquisition computed on the bases set out in Rule 1006 of the Singapore Exchange Securities Trading Limited Listing Manual Section B: Rules of Catalyst (the “**Listing Manual**”) amount to less than 5%, the Acquisition falls under the category of “Non-Disclosable Transactions” under Rule 1008 of the Listing Manual.

Accordingly, the Company’s equity interest in TSG has increased to 1,195,714 ordinary shares and TSG is now a 93.0%-owned subsidiary of the Company. The Acquisition will be funded through internal resources and/or external borrowings.

None of the Directors or controlling shareholders of the Company and their respective associates has any interest, direct or indirect, in the Acquisition (other than through their respective shareholdings in the Company, if any).
