However, pursuant to section 136 of the Securities and Futures Act, Breedens is filing this notification form to report only the change in interest from 29.21% to 29.12% in the voting shares of the Listed Issuer which arises from a change in the total number of issued shares of the Listed Issuer from 2,396,503,869 to 2,404,328,869 (the "Transaction"). The percentage of interest immediately before and after the Transaction is calculated on the basis of 2,396,503,869 and 2,404,328,869 issued shares of the Listed Issuer respectively.</p>
