# **RESULTS OF EXTRAORDINARY GENERAL MEETING HELD ON 30 NOVEMBER** 2016

Pursuant to Rule 704(16) of the Listing Manual of Singapore Exchange Securities Trading Limited, the Board of Directors of Pan-United Corporation Ltd (the "Company") wishes to announce that at the Company's Extraordinary General Meeting ("EGM") held today, the ordinary resolution contained in the Notice of EGM dated 15 November 2016 was duly passed by way of poll.

#### (1) Breakdown of all valid votes cast at the EGM

The results of the poll on the ordinary resolution put to the vote at the EGM are set out below for information:

## (2) Details of parties who are required to abstain from voting on the resolution, including the number of shares held

As set out in paragraph 8.2 of the Circular to Shareholders dated 15 November 2016, each of Jane Kimberly Ng Bee Kiok, Ng Bee Bee and Ng Han Whatt will abstain, and has undertaken to ensure that his/her respective associates (including Patrick Ng Bee Soon, a Director and Substantial Shareholder, who is deemed to be an associate under the Listing Manual by virtue of him being a sibling of Jane Kimberly Ng Bee Kiok, Ng Bee Bee and Ng Han Whatt) will abstain, from voting on the ordinary resolution to approve the Proposed Disposal as set out in the Notice of EGM.

Based on the information available to the Company as at the date of EGM on 30 November 2016, the following table sets out the parties who are required to abstain from voting and who had abstained from voting on the ordinary resolution in respect of the Proposed Disposal at the EGM:
