The change in Mr. Pun Chi Tung Melvyn's interest is a consequence of the vesting of 1,650,000 share awards representing 33% of the total share awards granted to him on 4 April 2022 pursuant to the Yoma Performance Share Plan and approved by shareholders at the Annual General Meeting of the Company held on 27 July 2023.
