Incorporation of a new valve services company - ForgacsValco

The workshop will be a well-equipped, best-in-class facility.”

Valco Group Australian is a 100% owned subsidiary of Valco Group France, who are an original manufacturer of the valves SNRI, MALBRANQUE & GUICHON, specializing in service applications for the marine, defence, oil & gas, petrochemicals, power generation & industrial markets.

The incorporation of ForgacsValco was funded through internal resources and will not have any material impact on the net tangible assets per share and earnings per share of the Group for the financial year ending 30 June 2017.
