ANNOUNCEMENT OF COURT JUDGEMENT

Unless otherwise defined herein, all capitalised terms used in this announcement shall bear the same meanings as ascribed to them in the Company's announcements made on 20 August 2016, 30 August 2016, and 3 November 2016.

The board of directors (the **"Board"** or the **"Directors"**) of China Star Food Group Limited (the **"Company"** and together with its subsidiaries, the **"Group"**) refers to the previous announcement made on 3 November 2016 in relation to the service of the Writ of Summons on the Company by Mr Cheong Chee Hwa (**"CCH"**). Pursuant to the Writ, CCH had made a claim for the sum of S\$2,544,696.00 or damages to be assessed, for certain breaches alleged to have been committed by the Company under a sale and purchase agreement dated 5 November 2014 previously entered into between, *inter alia*, the Company and CCH (the **"SPA"**), as was subsequently amended or supplemented (the **"Supplemental Agreement"**), in relation to the sale of CCH's shares in China Star Food Holdings Pte. Ltd. to the Company in connection with the Company's reverse takeover.

The Board wishes to announce that the trial has been concluded and that the Singapore High Court (the **"Court"**) had released its written judgement on 29 March 2019 (the **"Judgement"**). The Court had dismissed CCH's claims against the Company. The salient points of the Judgement are:

- (i) CCH had failed to show that there had been a breach of the SPA or the Supplemental Agreement;
- (ii) CCH had failed to prove the implied term in which he had alleged that the Company was not to unilaterally undermine the value of the shares, and hence the value of the shares issued to him; and
- (iii) costs of the lawsuit are to be awarded to the Company.

CCH has one (1) month from the date of the Judgement to appeal the decision to the Court of Appeal of Singapore, that is, by 29 April 2019.
