APPOINTMENT AS AUTHORISED RESELLER OF CYBERARK SOFTWARE (SINGAPORE) PTE. LTD.

The Board of Directors of Secura Group Limited (the "Company", together with its subsidiaries, the "Group") is pleased to announce that the Company's wholly-owned subsidiary, Soverus Technology Pte. Ltd. ("STPL") has on 4 May 2016 entered into an APAC Reseller Agreement (the "Distribution Agreement") with CyberArk Software (Singapore) Pte. Ltd. ("CyberArk"), a company incorporated in Singapore and is a wholly-owned subsidiary of CyberArk Software, Ltd..

Under the terms of the Distribution Agreement, STPL has been appointed by CyberArk as a non-exclusive reseller of CyberArk's brand of products within Singapore ("**Appointment**"). This Appointment is in addition to being the authorised channel partner of other cyber security products of leading information technology security enterprises, including LogRhythm, Aruba, Rapid7, Heat Software, Dell Software, Watchguard, Skybox and Mojo Networks (formerly known as AirTight Networks). This Appointment enhances the Group's product portfolio for expansion in the cyber security business.

This Appointment is not expected to have any significant impact on the earnings per share and net asset value per share of the Group for the financial year ending 31 December 2016.

None of the Directors or substantial shareholders of the Company has any interest, directly or indirectly, in the Appointment, save for their shareholdings in the Company.
