## **SIGNING OF SERVICE AGREEMENT WITH SATA COMMHEALTH**

The Group’s entry into the Agreement is not expected to have any material impact on the net tangible assets per share and earnings per share of the Group for the financial year ending 31 December 2018.

None of the Directors, substantial shareholders or controlling shareholders of the Company has any interest, directly or indirect, in the above transaction, other than through their respective interests (if any) in the Company.
