

VOLUNTARY PRE-CONDITIONAL CASH PARTIAL OFFER FOR KEPPEL CORPORATION LIMITED

1. Introduction

Morgan Stanley Asia (Singapore) Pte. (“MS Singapore”) refers to the announcement dated 21 October 2019 made by MS Singapore on behalf of Kyanite Investment Holdings Pte. Ltd. (the “Offeror”), an indirectly wholly-owned subsidiary of Temasek Holdings (Private) Limited (“Temasek”) to acquire such number of ordinary shares in the capital of Keppel Corporation Limited (the “Company” or “Keppel”) that would result in the Offeror and Temasek having an aggregate direct holding in 51.00 percent of Keppel (the “Partial Offer”) of the total number of ordinary shares in issue (excluding ordinary shares held in treasury) as at the specific record date. MS Singapore is the sole financial advisor to the Offeror in respect of the Partial Offer.

2. Dealings

Pursuant to Rule 12.1 of the Singapore Code on Takeovers and Mergers (the “Code”) and the Practice Statement on the Exemption of Connected Fund Managers and Principal Traders under the Code, MS Singapore wishes to report that on 24 October 2019, associates of MS Singapore dealt in the securities (“**Relevant Securities**”) of Keppel for their own account or for the account of discretionary investment clients, details of which are as follows:
