**UPDATES ON THE RECEIPT OF LISTING AND QUOTATION NOTICE IN RELATION TO THE  
265,000,000 SUBSCRIPTION SHARES**

The board of directors (the “**Board**” or the “**Directors**”) of Capital World Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) refers to the circular to shareholders dated 11 January 2019 (the “**Circular**”), the Company’s announcement dated 31 January 2019 in relation to the receipt of a listing and quotation notice from the SGX-ST (the “**Notice**”) for the listing and quotation of 265,000,000 Subscription Shares, up to 44,000,000 Subscriber Option Shares and up to 50,000,000 Referrer Option Shares and dated 14 February 2019 (“**14 Feb Announcement**”) in relation to update on the receipt of the Notice (the “**Previous Announcements**”). Unless otherwise defined, capitalised terms used in this announcement shall bear the same meanings as ascribed to them in the Circular and the Previous Announcements.

As disclosed in the 14 Feb Announcement, the Subscription Shares had not been issued to the Subscriber on 13 February 2019, being the end of seven (7) market days, as the Company was pending the receipt of funds from the Subscriber. In view of the completion of the Proposed Subscription and Grant of Options on 14 March 2019, the Company had resubmitted the application to the SGX-ST, via its sponsor, for the listing and quotation of 265,000,000 Subscription Shares.

The Board is pleased to announce that the Company has on 15 March 2019 received the listing and quotation notice (the “**Updated Notice**”) from the SGX-ST for the listing and quotation of 265,000,000 Subscription Shares, subject to compliance with the SGX-ST’s listing requirements.

Pursuant to the Updated Notice, the Subscription Shares have to be placed out within seven (7) market days from the date of the Updated Notice.

The Updated Notice is not an indication of the merits of the Subscription and Options Agreement, the Subscription Shares, the Company, its subsidiaries and their securities.
