ANNOUNCEMENT TO THE COMPANY'S SINGAPORE SHAREHOLDERS

The Company refers to:

1. Notification of Delisting from the Singapore Exchange Securities Trading Limited (SGX) dated 15 July 2019
2. The Company Announcement to Shareholders dated 19 July 2019

The Company would like to convey further information to the Company's Singapore Shareholders in connection with the removal of the Company's shares from the SGX. The Company has intensively been communicating with the SGX and Indonesia Capital Market Regulators (Financial Services Authority (OJK), Indonesia Stock Exchange (IDX), Indonesia Central Securities Custodian (KSEI), and Share Registrar PT Sinartama Gunita).

Considering the input from the parties above and recognizing the nature and characteristics of the Company's share, the Company hereby conveys as follows:

1. The Company's share listed in SGX is a fully fungible shares.
This enable the Singapore Shareholders to trade the shares in IDX as well (the shares tradeable in both exchange).
2. Due to the removal of Company shares from the SGX trading platform, and refer to point 1 above, the Company would invite the Singapore Shareholders to move their shares from SGX to IDX. The mechanism for transferring shares are as follows:
 - a. For the shareholders who have existing security account with IDX member, to start trading via their security account with broker (security firm) or custodian bank registered in IDX so that the shareholders can request CDP to do transfer shares.
 - b. For the shareholders who do not have existing security account with IDX member, to open security account via broker (security firm) or custodian bank registered in IDX so that the shareholders can request CDP to do transfer shares.

The Company will provide 30 days upon the date of this announcement made to the Singapore Shareholders to prepare opening security account for transferring the shares to the IDX member. Once the given time limit ends and there are still Shareholders who have not transfered the shares to their security account at IDX member, then these Singapore Shareholders will receive shares in script (physical certificate). The Company will send the issued share certificate to each shareholders based on the latest shareholders data issued by

CDP upon request. Please note that the script shares cannot be traded in the IDX as it is but must be converted into scriptless before the shares are able to trade on IDX platform.

Dispatching the Share Certificate.

The Singapore Shareholder may ask the Company to mail the share certificate to the destination requested by the Singapore Shareholders. The request to mail the share certificate must be made in written through email at Investor@blt.co.id.
