FURTHER UPDATE ON RECEIPT OF SEALED WRIT AND STATEMENT OF CLAIM

*Any capitalized but undefined terms used herein shall have the same meanings as those used in the announcements dated 23 February 2022, 24 August 2022, 7 October 2022, 11 April 2023, 9 May 2023 and 31 October 2023 (the “**31 October 2023 Announcement**”) (collectively, the “**Announcements**”) issued by Versalink Holdings Limited (the “**Company**”).*

The board of directors (the “**Board**”) of the Company refers to the Announcements in relation to (i) the receipt of the Sealed Writ and Statement of Claim filed by Ahmad Zaki Sdn Bhd (“**AZSB**”) against the Company’s wholly-owned subsidiary, Versalink Marketing Sdn Bhd (“**VLM**”); (ii) the adjudication decision received by VLM dated 8 August 2022 (as corrected on 18 August 2022) (“**Adjudication Decision**”); (iii) the sealed orders by the Malaysia High Court (“**Court**”) received by VLM on 7 April 2023 (the “**Orders**”) that the two separate applications filed by AZSB to stay and set aside the Adjudication Decision respectively are dismissed with costs payable by AZSB to VLM and that the application filed by VLM to enforce the Adjudication Decision is allowed with no order as to costs; (iv) the sealed cause papers from the solicitors for AZSB received by VLM on 2 May 2023 that two separate Notice of Appeal dated 2 May 2023 to appeal against the Court’s decision to dismiss AZSB’s application to stay and set aside the Adjudication Decision respectively; (v) the sealed cause papers from the solicitors for AZSB received by VLM on 5 May 2023 in relation to a Fortuna Injunction to restrain VLM from presenting a winding up petition against AZSB; (vi) the Winding-Up Petition (“**Petition**”) which was served by VLM against AZSB and the Petition was also presented to the Court on 10 May 2023; (vii) the sealed order by the Court where the Court dismissed AZSB’s Notice of Motion to stay the winding-up proceedings and stay the advertisement of the Petition on 4 October 2023; (viii) the sealed order by the Court where the Court dismissed AZSB’s Notice of Application to set aside the sealed Ex-Parte Order to show cause dated 23 June 2023 (“**Garnishee Ex-Parte Order**”) and to stay the Garnishee proceedings on 5 October 2023; and (ix) the sealed Garnishee order by the Court where the Court granted a Garnishee Order Absolute against the Garnishees (“**Garnishee Order**”) during the hearing for show cause on 5 October 2023. For more information on the aforementioned matters, please refer to the Announcements.

The Board wishes to update shareholders of the Company (“**Shareholders**”) of the following:

- (a) During the hearing of the winding-up proceedings against AZSB and AZSB’s 2nd Notice of Motion to stay the winding-up proceedings held on 28 November 2023, in view that AZSB had paid the outstanding sum of RM1,116,868.38 to VLM on 27 November 2023, the Court directed the Petition be struck off with cost of RM10,000 to be paid by AZSB to VLM and also directed that the deposit of RM3,000 be refunded by Malaysia Insolvency Department to VLM. In view that the Petition is now struck off, the Court also directed that AZSB’s 2nd Notice of Motion be struck off with costs of RM3,000 to be paid by AZSB to VLM.
- (b) The trial for the civil suit initiated by AZSB against VLM on 18 February 2022 whereby AZSB claimed for a sum of RM1,679,815.82, whilst VLM had counterclaimed against AZSB for a sum of RM1,543,867.81 will be held in January 2024.

The Company will update Shareholders and potential investors of the Company on any further material development(s) of the abovementioned matters by way of a further announcement(s), as and when necessary, in accordance with Singapore Exchange Securities Trading Limited Listing Manual Section B: Rules of Catalist.
