ENTRY INTO A NON-BINDING MEMORANDUM OF UNDERSTANDING

The board of directors ("Board") of Alliance Healthcare Group Limited (the "Company" or "Alliance Healthcare" and together with its subsidiaries, the "Group") is pleased to announce that the Company's subsidiary, Jaga-Me Pte. Ltd. ("Jaga-Me"), had on 21 March 2025 entered into a non-binding memorandum of understanding ("MOU") with National University Hospital (Singapore) Pte Ltd ("NUH") to establish a working relationship and a foundation for collaboration in the areas of supportive and palliative care services (the "Collaboration").

Pursuant to the MOU, NUH and Jaga-Me wish to establish a working relationship and a foundation for collaboration in the areas of (a) NUH's Healthier SG and Age Well SG options; (b) NUH's supportive care and palliative care options; (c) review of terminal discharge. One potential area of focus of the Collaboration is to enable more terminally ill patients to receive care at home, addressing concerns about access to professional home-based palliative care. This aims to provide patients with greater control over their end-of-life journey, allowing them to spend their final days in the familiar comfort of their own home, surrounded by loved ones.

Commenting on the Collaboration, Ms Sapphire Tham, Chief Executive Officer of Jaga-Me said, "Collaborating with NUH on supportive and home palliative care services is a significant step forward in expanding access to home-based care, and fulfilling terminally-ill patients' wishes to return home. We are excited about the meaningful benefits this partnership will bring to our patients and the healthcare community."

The MOU is not expected to have any material impact on the Group's financial results for the current financial year ending 30 June 2025. None of the Company's directors, controlling shareholders and/or their respective associates have any interest, direct or indirect, in the MOU.
