While Form C will be attached to the announcement template, it will not be disseminated to the public and is made available only to the Monetary Authority of Singapore (the "Authority").

International Press Holdings Pte Ltd ("IPH") is the holding company of International Press Softcom Limited ("Company"). IPH is equally owned by Ze Hua Holdings Pte. Ltd. ("Ze Hua") and Chee Chun Holdings Pte. Ltd. By virtue of Section 4 of the Securities and Futures Act, Chapter 289 of Singapore, Mr Low Song Take is deemed interested in the shares in the capital of the Company by virtue of his shareholding in Ze Hua.

The increase in deemed interest is pursuant to the allotment and issuance of 237,243,084 new shares to IPH under the Rights Issue.
