## ISSUE OF S\$50,000,000 6.00 PER CENT. NOTES DUE 2018 UNDER THE S\$500,000,000 MULTICURRENCY MEDIUM TERM NOTE PROGRAMME OF INTERNATIONAL HEALTHWAY CORPORATION LIMITED

---

Further to the announcement dated 30 January 2015, the board of directors (the "**Board**") of International Healthway Corporation Limited (the "**Issuer**") is pleased to announce that it has today issued S\$50,000,000 6.00 per cent. Notes due 2018 (the "**Series 1 Notes**") under its S\$500,000,000 multicurrency medium term note programme (the "**Programme**").

The Hongkong and Shanghai Banking Corporation Limited acted as sole bookrunner and The Hongkong and Shanghai Banking Corporation Limited and CIMB Bank Berhad acted as joint lead managers in relation to the Series 1 Notes.

The Series 1 Notes were issued at an issue price of 100 per cent. of their principal amount and in denominations of S\$250,000. The Series 1 Notes will bear interest at a fixed rate of 6.00 per cent. per annum payable semi-annually in arrear and will mature on 6 February 2018.

The Notes constitute direct, unconditional, unsubordinated and unsecured obligations of the Issuer and shall at all times rank *pari passu*, without any preference or priority among themselves, and *pari passu* with all other present and future unsecured obligations (other than subordinated obligations and priorities created by law) of the Issuer.

The net proceeds arising from the issue of the Series 1 Notes (after deducting issue expenses) will be used for general corporate purposes, including financing investments, repayment of existing borrowings, general working capital and capital expenditure requirements of the Issuer and/or its subsidiaries.

Pursuant to Condition 5(e)(ii), a "Change of Shareholding Event" will occur when Fan Kow Hin, Aathar Ah Kong Andrew and Jong Hee Sen and their Immediate Family Members (as defined in the Conditions) cease to own in aggregate (whether directly or indirectly) at least 30 per cent. of the issued share capital of the Issuer. Upon the occurrence of a "Change of Shareholding Event", each holder of the Series 1 Notes has an option to require the Issuer to redeem the Series 1 Notes of such holder (subject to the Conditions).

Approval in-principle has been received from the Singapore Exchange Securities Trading Limited (the "**SGX-ST**") for the listing and quotation of the Series 1 Notes on the SGX-ST. Approval in-principle from, admission to the Official List of, and the listing and quotation of the Series 1 Notes on, the SGX-ST are not to be taken as an indication of the merits of the Issuer, its subsidiaries (if any), its associated companies (if any), its joint venture companies (if any), the Programme or the Series 1 Notes. The Series 1 Notes are expected to be listed on the SGX-ST on 9 February 2015.

Terms defined in the information memorandum dated 23 January 2015 in relation to the Programme shall have the same meaning in this announcement unless otherwise defined herein.
