UPDATES ON THE GROUP'S OPERATIONS IN RELATION TO COVID-19

1. The Board of Directors (the "**Board**" or the "**Directors**") of Aoxin Q & M Dental Group Limited (the "**Company**", and together with its subsidiaries, the "**Group**") refer to its announcement dated 15 November 2021, on the impact of COVID-19 on the Group's operations in Liaoning Province, People's Republic of China ("**PRC**").
2. Subsequent to our announcement on 15 November 2021, our operation in Dalian city, namely Dalian Aoxin Quanmin Stomatology Hospital Co., Ltd. has been temporarily closed from 19 November 2021 until 3 December 2021, as directed by the Health Commission of Dalian City, in accordance with the government prevention and control policy requirements, due to the situation of COVID-19.
3. The Group wishes to announce that following dental hospital and polyclinics had resumed operations after we have fulfilled the required standard operating procedures and have met the reopening criteria governed by the Health Commission.

We set out the details of the dental hospital and polyclinics for operation resumption, as follows:

4. The Group will continue to monitor the situation closely, maintain communications with the relevant authorities and implement additional short-term precautionary measures, if required.

5. The Board will keep our Shareholders updated on any further material impact of COVID-19 on the Group's business activities.
