While Form C will be attached to the announcement template, it will not be disseminated to the public and is made available only to the Monetary Authority of Singapore (the "Authority").

1. MLHS Holdings Pte. Ltd. ("MLHS") holds more than 50 per cent. of the issued shares in Aspial Corporation Limited ("Aspial") and is deemed to have an interest in any Maxi-Cash Shares held by Aspial.
2. Koh Wee Seng holds a direct interest of 19.27 per cent. of shares in Aspial. In addition, Koh Wee Seng also holds more than 20 per cent. of the issued shares in MLHS. Koh Wee Seng is accordingly deemed to have an interest in any Maxi-Cash Shares in which MLHS has an interest.
3. Further, pursuant to the Securities and Futures Act, Koh Wee Seng is deemed to have an interest in any Maxi-Cash Shares held by his spouse.
4. Accordingly, immediately after the Transfer, Koh Wee Seng has:
  - (i) a direct interest in 121,198,396 Maxi-Cash Shares, representing approximately 11.71 per cent. of the total number of Maxi-Cash Shares in issue; and
  - (ii) a deemed interest in (a) 669,954,669 Maxi-Cash Shares in which Aspial has an interest, representing approximately 64.72 per cent. of the total number of Maxi-Cash Shares in issue (excluding treasury shares); and (b) 264,751 Maxi-Cash Shares in which Koh Wee Seng's spouse has an interest, representing approximately 0.026 per cent. of the total number of Maxi-Cash Shares in issue (excluding treasury shares).
