UPDATE ON PROPOSED ACQUISITION

The Board of Directors of Geo Energy Resources Limited (the "Company") (SGX:RE4) refers to its announcement dated 30 August 2019 relating to the potential acquisition of new coal assets for a producing coal mine in East Kalimantan, Indonesia (the "Potential Transaction").

The Company has been informed by the owners of the coal mine that the sale process has been postponed. Accordingly, the Potential Transaction is put on hold. If the sale process is resumed by the owners of the coal mine, the Company will assess the merits of the transaction based on prevailing circumstances before deciding whether to continue to participate in the sale process.
