CLA Real Estate Holdings Pte. Ltd.'s (formerly known as Ascendas-Singbridge Pte. Ltd.) ("CLA") deemed interest in the units in ART ("Units") arises through its subsidiary, CapitaLand Limited ("CL").

CL is deemed to have an interest in the unitholdings of its wholly-owned subsidiaries, The Ascott Limited ("Ascott"); Somerset Capital Pte Ltd ("SCPL"); and ARTML. As at 13 August 2019, Ascott has a direct interest in 476,152,416 Units; SCPL has a direct interest in 314,137,188 Units; and post issuance of the 2,041,229 Units by ART to ARTML on 13 August 2019, ARTML has a direct interest in 189,586,278 Units. CL is therefore deemed to have an interest in a total of 979,875,882 Units as at 13 August 2019.
