Market acquisition of 412,300 ordinary shares in the capital of the Company ("Shares") by Handojo Santosa and Farida Gustimego Santosa. Following the acquisition, Handojo Santosa and Farida Gustimego Santosa jointly own 12,662,300 Shares.

The remaining Shares in which Handojo Santosa is deemed to have an interest are held by Rangi Management Limited ("Rangi") and Tasburgh Limited ("Tasburgh") under the Scuderia Trust (1,055,082,615 Shares) and by Tallowe Services Inc. ("Tallowe") (81,000,000 Shares). The beneficiaries of the Scuderia Trust are Handojo Santosa's spouse (Farida Gustimego Santosa), children (Renaldo Santosa, Gabriella Santosa, Mikael Santosa and Raffaela Santosa) and remoter issuer. Pursuant to Section 4 of the Securities and Futures Act (Cap. 289) (the "SFA"), the beneficiaries of the Scuderia Trust are deemed to have an interest in the Shares held by Rangi and Tasburgh. Under the terms of the Scuderia Trust, Handojo Santosa is entitled, as an investment power holder, to direct the trustee of the Scuderia Trust to procure to the best of its ability that the directors of Fusion Investment Holdings Limited ("Fusion") and Tasburgh act in accordance with his instructions in relation to the investments of the Scuderia Trust. As the sole shareholder of Rangi, Fusion is entitled to determine the composition of the board of directors of Rangi. Accordingly, Handojo Santosa can control the exercise of the rights of the shares held by Fusion in Rangi and through the board of directors appointed by Fusion, control the exercise of the rights of the Shares held by Rangi under the Scuderia Trust. By virtue of Section 4 of the SFA, Handojo Santosa is deemed to have an interest in the Shares held by Rangi and Tasburgh.

For the purpose of Section 133(4)(a) of the SFA, a director of a corporation shall be deemed to have an interest in shares in the corporation of which he is a director if his family members (being his spouse and children below the age of 21 years) holds or has an interest in those shares. This notification is also being made under Section 133(1) (g), read with Section 133(4)(a), of the SFA as Handojo Santosa's spouse has also acquired an interest in the 1,200,000 Shares by virtue of the aforementioned acquisition through the joint client account. As the beneficiaries of the Scuderia Trust include Handojo Santosa's spouse and several of his children below the age of 21 years, who as beneficiaries of the Scuderia Trust are deemed to have an interest in the Shares held by Rangi and Tasburgh, Handojo Santosa is also deemed to be interested in the Shares held by Rangi and Tasburgh for the purposes of Section 133 of the SFA.

The shares of Tallowe are held by Magnus Nominees Limited and Fidelis Nominees Limited as bare trustees for Handojo Santosa. By virtue of Section 4 of the SFA, Handojo Santosa is deemed to have an interest in the Shares held by Tallowe.
