(b) Transurban Properties Pte. Ltd. has a direct interest in 56,342,854 shares. The Estate has a controlling interest in Glory Realty Co. Private Ltd, which in turn has a controlling interest in Transurban Properties Pte. Ltd.. PN is a beneficiary of the Estate and is therefore deemed to be interested in the 56,342,854 shares in which Transurban Properties Pte. Ltd. has an interest.
